Description:	<p><b>Purpose</b> The purpose of this CIT is to provide CalSAWS counties with the Batch Memorandum for <b>SCR CA-233027 ACL 21-140 Run Batch EDBC for Pregnancy Special Need (PSN) Increase</b>.</p> <p><b>Background</b> <a href="#">ACL 21-140</a> expands eligibility for CalWORKs for pregnant person only (PPO) applicants effective July 1, 2022 and increases the monthly PSN payment to \$100 effective May 1, 2022.</p> <p>SCR CA-232069 made several changes related to the PSN amount:</p> <ul style="list-style-type: none"> <li>Updated Special Needs Code Table for Pregnancy to \$100 effective 5/1/2022.</li> <li>Added new Batch Run Reasons for running Batch EDBC to update the PSN to the new amount for 5/1/22.</li> <li>Updated the \$47 PSN NOA to reflect the \$100 update.</li> </ul> <p><b>Additional Information:</b> SCR CA-233027 Run Batch EDBC for Pregnancy Special Need (PSN) Increase will run on Sunday, April 17, 2022, to increase the PSN amount on eligible cases. Batch EDBC will run for CalWORKs (CW) and Refugee Cash Assistance (RCA) programs</p>
