Description: (Including any step-by-step instructions)	<p>Purpose</p> <p>The purpose of this CIT is to notify counties of an alternate procedure to issue childcare payments for children over thirteen years of age.</p> <p>Background</p> <p>Child Care Bulletin No.22-04 clarifies CalWORKs Stage One Child Care immediate and continuous eligibility age requirements. Children whose initial certification or recertification occurs prior to the child's thirteenth birthday may receive subsidized childcare services for the duration of their 12-month eligibility period.</p> <p>Additional Information:</p> <p>CalSAWS does not allow issuance of a childcare payment for a child over the age of 12 years and 11 months. SCR CA-243470 targeted for Release 23.03 has been opened to allow childcare payments for children over thirteen.</p> <p>County Action:</p> <p>County users can issue a childcare payment for children who are over thirteen years of age and eligible for childcare by updating the Child Care Need Detail page field Child's Special Need to 'Mental/Physical Needs (13+)' and the Verified field to "Not Applicable" for the eligible child.</p> <p>For questions regarding this CIT, please contact the primary contacts listed below and copy your Regional Manager(s) (RMs).</p>
