 When a youth is removed from the Non-Related Legal Guardian (NRLG) and placed in

Foster Care, the Placement Authority of Non-Related Legal Guardianship is end-dated and a new Placement Authority of Child Welfare Services Court Order is created. When the youth is returned back to the NRLG, a new Placement Authority of Non-Related Legal Guardianship is created.

Currently, EDBC evaluates the 'Begin Date' of the Placement Authority of Non-Related Legal Guardianship as the Legal Guardianship granted date, which is creating an inaccurate rate. CalSAWS is issuing the most current rate instead of the correct Rate Table (when Legal Guardianship was granted).
