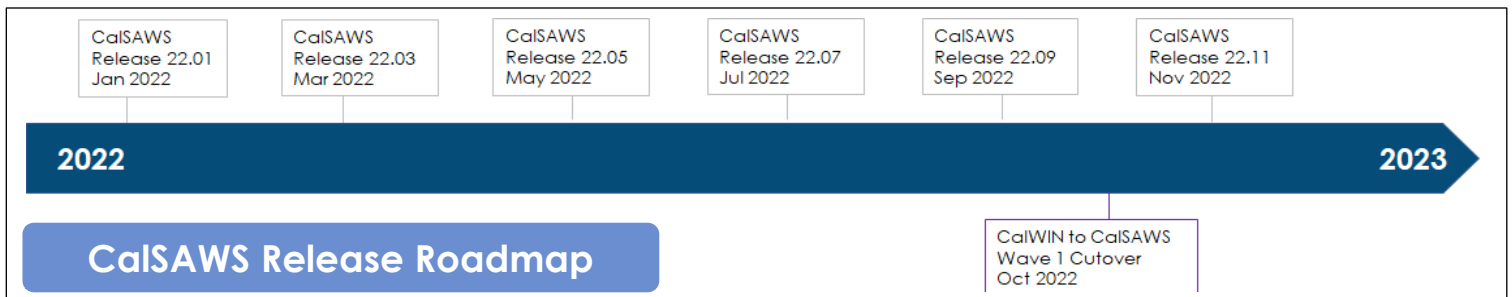


## Volume 4 | Issue 3: Hello Summer!

We are testing and finalizing the 22.07 July Release for the 40 CalSAWS Counties and preparing for the eventual end of the Public Health Emergency.

The CalSAWS team conducted a successful communications focus group and will be taking the feedback received to make improvements in the future.

### Tech Tips



#### Hidden and Duplicate Persons; Did you know?

- Most CalSAWS Data Collection pages don't show hidden persons. From the left navigation menu on the Case Summary page, click Hide Person to see if anyone is hidden in the current case.
- CalSAWS MAGI Determinations and EDBC's exclude or mark as "Out of the Home" persons who are duplicates. Workers with Edit rights can click "Duplicate List" on the bottom of the Individual Demographics page while in edit mode.

#### Avoid stale MAGI Determinations in Medi-Cal EDBC!

- Medi-Cal EDBC will use the most recent MAGI Determination as part of its evaluation. For cases with a potential change to MAGI Eligibility, request a new MAGI Determination and wait for the MAGI Determination Response before running Medi-Cal EDBC.

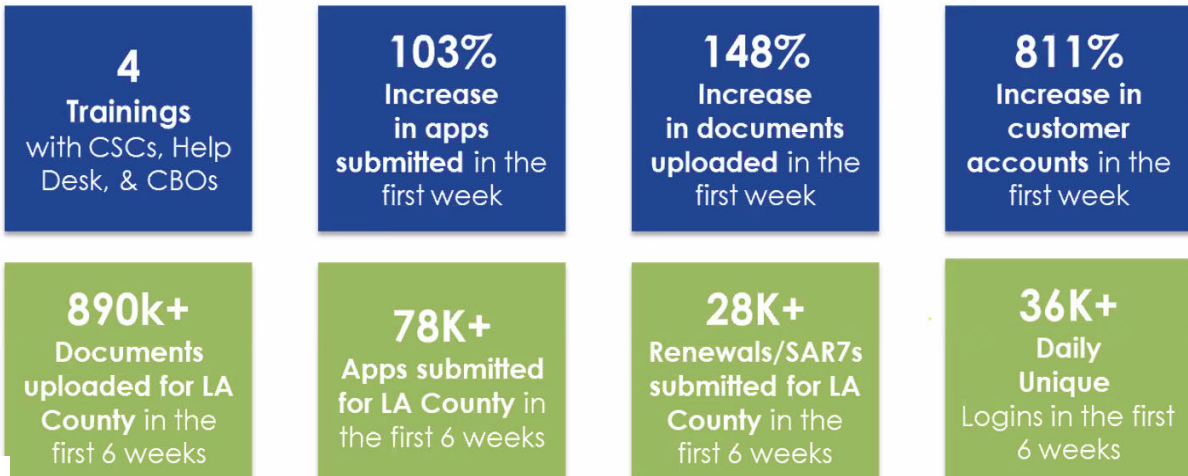
- ◇ **29** Open Defects.

## BenefitsCal

- **Threshold languages:** 3 new threshold languages are deployed to production within the 5/26 monthly release (Thai, Ukrainian, Mien)
- **Upcoming Enhancements:** Two Way Messaging is on schedule for the July Release. Initial version of the design is completed for the Student Based Archetypes and CBO Referral code for September Release.
- **Collaboration Model:** Working with Consortium leadership on Collaboration model. Next meeting is scheduled for 6/17
- **Los Angeles County Post Go-Live:** Continued to provide post go-live monitoring. Facilitated two webinars to LA County CBOs on 5/16 and 5/17 with LA County, Consortium and partner teams with around 160 unique participants.



## Regional Manager Updates

Many of the Regional Managers (RMs) are traveling again and attending Business Process Reengineering (BPR) sessions in the counties as well as educational session site visits to assist in highlighting helpful functionality.

The RMs also partnered with App/Dev testing to transition the counties from the CalSAWS Consortium County Validation (CCCV) pilot phase of 23.03 into the ongoing CCCV process for 22.05 forward. Counties successfully partnered to validate functionality and report any identified defects which resulted in fixes being applied before the Release went to production. The RMs and other project team members look forward to a positive collaboration with the counties to continue testing new functionality for the CalSAWS. 🐝

### CalSAWS Communication Focus Group

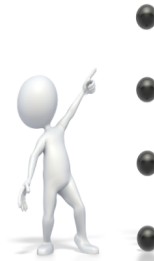
The CalSAWS Communication County Focus Group was conducted on May 25, 2022 and was a great success. The session was designed to be both informative and interactive which resulted in meaningful feedback from county participants. Counties weighed in on their top communication priorities which are being socialized within the project. Participants will be receiving notification shortly on the initial communication “experiments” teams will begin work on. Most will require smaller focus group sessions so CRFIs will follow the notification to identify county participants. A communications infographic was also developed and distributed to those who participated in the session. The infographic highlighted a few questions raised during the session and pointed readers towards resources available. A “Did you Know” CIT will be released this week that includes the Communications infographic for distribution across all Counties.
