

AMENDMENT NO. 36

This Amendment No. 36 (“Amendment”) is entered into as of September 1, 2022 (the “Effective Date”), by and between the CalSAWS Consortium, a joint powers authority (herein referred to as “CalSAWS” or “Consortium”), and Regional Government Services Authority (“RGS”), a joint powers authority. This Amendment No. 36 shall amend the Amended and Restated Agreement for Management and Administrative Services between the parties, dated March 1, 2022, as amended (the “Agreement”).

IT IS HEREBY AGREED AS FOLLOWS:

1. Attached to this Amendment is Exhibit A: Scope of Services, dated September 1, 2022, which replaces all previous Exhibit A: Scope of Services attached to the Agreement, in their entirety.
2. This Amendment No. 36 renames the position of Information Technology Manager to BenefitsCal Manager in Exhibit A: Table 1, Range of Bill rates For Personnel and Travel Reimbursement Policies and in Exhibit A: Table 2, Staff Salary Rate Schedule.
3. This Amendment No. 36 adds the position description and allocation for Application Development Manager in Exhibit A: Table 1 Range of Bill Rates for Personnel and Travel Reimbursement Policies, Exhibit A: Table 2, Staff Salary Rate Schedule, and Exhibit B: Job and Services, Part 1, Job Descriptions.
4. This Amendment No. 36 combines BenefitsCal Manager and Application Development Manager Job into a single line entry in Exhibit A: Table 1, Range of Bill rates for Personnel and Travel Reimbursement Policies and in Exhibit A: Table 2, Staff Salary Rate Schedule.
5. This Amendment No. 36 adjusts Exhibit A, Table 1, Range of Bill Rates for Personnel and Travel Reimbursement Policies to update the number of position allocations for the following positions: Business Analyst II, Technical/Security Analyst I/II, and Regional Manager II.
6. This Amendment No. 36 adjusts the Minimum rate for Business Consultant in Exhibit A: Table 1, Range of Bill rates for Personnel and Travel Reimbursement Policies.
7. This Amendment No. 36 adds a sub-section to the Compensation Section of the agreement describing the procedure and policy for Temporary Assignment Pay.
8. This Amendment No. 36 modifies the qualifications nomenclature of certain Job Descriptions from a statement of “must have” to defining qualifications as “typically includes” in Exhibit B: Job and Services, Part 1 Job descriptions
9. Except as specifically provided in this Amendment No. 36 all other terms and conditions of the Agreement are unchanged and remain in full force and effect.
