<b>Description:</b> (Including any step-by-step instructions)	<p><b>Purpose</b></p> <p>The purpose of this CIT is to notify CalSAWS counties that a list, for reference only, has been generated with cases that had a data change to update information based on changes to the Federally-Recognized Tribes in CalSAWS. The changes are also made in the CalHEERS system.</p> <p><b>Background</b></p> <p>System Change Request (SCR) CA-233347 <i>Addition of Federally-Recognized Tribes</i> for release 22.06 on June 20, 2022, will coincide with CalHEERS Change Request CR #174936 <i>Addition of Federally-Recognized Tribes</i>.</p> <p>SCR CA-233347, updates the Tribe Names that CalSAWS transfers through the Electronic Health Information Transfer (eHIT) to CalHEERS. Specific Federally-Recognized Tribes Names' have been updated to align with eHIT. Duplicate Federally-Recognized Tribes - 'Mdewakanton Sioux Indians' and 'Table Bluff Reservation -Wiyot Tribe' have been removed and associated with the correct corresponding Federally-Recognized Tribe and Removed one Federally-Recognized Tribe, and all State-Recognized Tribes have been removed. The information in CalHEERS is now aligned with the Federally-Recognized Tribes listed on National Conference of State Legislatures (NCSL) website found at <a href="https://www.ncsl.org">NCSL</a>.</p>

The Tribe Name updates should reduce the number of Errors that state: 'The code provided for TribeNameCode does not exist for SAWS Case Person: XX' sent by CalHEERS. These errors are displayed on the MAGI Request Error Detail page.

**Additional Information:**

The changes in CalSAWS includes:

- Updates individuals associated to a State-Recognized Tribe to be associated to Federally-Recognize Tribe, 'Tribe Not Listed'
- Update individuals associated to a removed, duplicate Federally-Recognized Tribe to the appropriate Federally-Recognized Tribe
- Removed duplicate Federally-Recognized Tribe 'Mdewakanton Sioux Indians'
- Removed duplicate Federally-Recognized Tribe 'Table Bluff Reservation-Wiyot Tribe' and associated it to the Federally-Recognized Tribe, "Wiyot Tribe (formerly the Table Bluff Reservation-Wiyot Tribe)
- Update individuals associated to an end-dated Federally-Recognized Tribe to Federally-Recognized Tribe, "Tribe Not Listed"

There will be no automated MAGI Eligibility Determination Request (EDR) or Medi-Cal EDBC Batch because of the Tribe Name association updates; a Data Change has been completed for the cases impacted.


The list of cases is posted to the CalSAWS Web Portal for **informational purposes only**. The changes may be seen on the Individual Demographics page when this data change is applied and when the next EDBC is processed for the case, the correct Tribe name will be displayed on the MAGI Person Detail page for the individual in a MAGI case. It is not necessary to run the case at this time solely due to this specific list.

A list will be posted to the web portal for Counties on Tuesday, June 21, 2022, for individuals who had their Tribe Name association changed. The lists columns are:

- Prior Tribe State-Recognized Yes/No
- Prior Tribe duplicate Federally-Recognized Yes/No
- Prior Tribe removed Federally-Recognized Yes/No
