Training environment touchpoint	 Reminder: Training environments are down the Mondays after a major release. Code is deployed to both environments (Training Staging and Training Production) and the project tests to validate the new code on these Mondays. Even if the environment is up, please do not use it until notified. Case Copy SCR CA-242895 will be released with the 22.07 release on July 25th. This SCR will modify how copied cases are assigned. Cases will be assigned to the first generic work ID for the County of the user that requested the copy. <u>Question:</u> Can ServiceNow tickets be submitted for the Training Environment? County received a response from the Tech team they do not support the Training Environment. Response: Yes, if you receive this response, please reach out to the training team.

	Question: Batch functionality is only available in UAT, can we make it available in the Training environments? This would be help for the SAR7 and RE scenarios. Response: Only case copy batch functionality is available in the Training environments. Other batch functionality can potentially be explored after the CalWIN counties migrate.			
	 <u>Question:</u> We used to have access to reports in the training environment, specifically the on request and staff management reports. This is how we kept track of who logged on during the trainings. Can we bring this back? Response: The platform used for reports was changed and therefore the training staging and production environments do not have ability to generate these reports anymore. We can revisit the request after the CalWIN Counties migrate. 			
	 <u>Question</u>: Will Training for Trainers include how to navigate/use the different training environments? Response: No, this will not be included. There will be a separate session about a month or two prior to your County Go-live that will walk you through the training environments. The names for who should have access to training staging will be requested via a CRFI. 			
	Reminder: Each County has only one batch job which copies from the different environments. The number of copies requested in the queue, impacts how long it takes for the copies to be available in Training production.
