Description: (Including any step-by-step instructions)	<p>Purpose (All Counties)</p> <p>The purpose of this CIT is to provide Counties information on the various CalSAWS Application Programming Interfaces (APIs) that are available for use by the county.</p> <p>Background</p> <p>During CalSAWS discovery sessions in 2019, Counties indicated they planned to continue to use some local ancillary systems (Lobby Management, Employment Services, etc.) and identified the real time data elements that were required to support those applications.
