Purpose

The purpose of this CIT is to inform the Wave 1 CalWIN Counties (Placer and Yolo) of the County Prep Phase Application Security & Managed Personnel Kickoff Meeting and supporting documentation that will be provided to support security configuration during County Prep. These resources will prepare Wave-1 CalWIN Counties for finalizing security assignments for each county user during the County Prep Phase, which starts Monday, September 19th, 2022, and goes through Thursday, October 27th, 2022.

Background

The CalSAWS conversion team will convert (up to five) Project-Maintained roles mapped to each county user. The mapping of project-maintained roles for each county user were initially selected with each Wave-1 County's response to CRFI 22-022. There is an updated CRFI that will be issued to Wave-1 counties, requesting confirmation of final mapping of project-maintained roles for each county user. This updated CRFI has not yet been sent to Wave-1 Counties. Wave-1 Counties will respond to this CRFI confirming project-maintained role assignments for each county user, and the assignments indicated in this CRFI response will be the initial mapping that your County Security Administrators will see in CalSAWS Production at the beginning of the County Prep phase. During the County Prep Phase, County

Security Administrators and/or other identified County Staff will have the opportunity to review and update security assignments for each county user. This will include the addition of County-Maintained Security Roles and assignment of those County-Maintained Roles to county users in addition to the project-maintained roles that were assigned as part of conversion.

Security Role Configuration Guide

The purpose of the Security Role Configuration Guide is to provide an additional tool to prepare and inform Wave 1 CalWIN Counties for creating County Maintained Roles and finalizing the appropriate security assignments to each county user during the County Prep Phase.

Additional Information

County Prep Phase Application Security & Managed Personnel Kickoff Meeting

The ISS Team will be hosting a Kickoff Meeting to introduce the Security Configuration documentation and supporting materials included with this CIT, as well as provide hands-on demonstration of the work that County Security Administrators will need to perform to finalize security assignments during the County Prep Phase. The kickoff will also provide an opportunity for County Staff to ask questions that they may have regarding the required actions that need to be taken during County Prep.

The targeted audience for this event will be County PPOCs, IPOCs, TPOCs, County Security Administrators, and any other County Staff who are responsible for making updates to security assignments in CalSAWS. The Kickoff Meeting **will be recorded** and available for viewing on the Web Portal.

The County Prep Phase Application Security & Managed Personnel Kickoff Meeting is scheduled for Tuesday, **September 6**, **2022**, **from 9:00 AM–11:00 AM**.

Meeting invites will go out to County PPOCs and IPOCS. County PPOCs/IPOCs will be responsible for distributing the invites to the appropriate individuals within their county.
