Background CalSAWS member Counties are required to pay a County Share of Costs of the CalACES, CalSAWS, and CalWIN systems. The County Share of Cost is calculated based on Persons Count. It was agreed that the method of payment would be in the form of an adjustment to each County's CalWORKs Administrative Advance. The Fourth Quarter of SFY 2021-22 will be applied to the October 2022 mid-month advance, reflecting each County's Share of Costs. The adjustment should be noted on each County's AA190.
