Due to Peraton's (export vendor) internal database work, CSV files will be available January 2023. Imaging's validation efforts will be delayed until such time as the CSVs are available. Sacramento County has proposed pushing the timeline by four months. Originally scheduled for October 15, 2022 Sacramento's document mapping has been postponed until December 31, 2022. The testing phase, originally scheduled to end on January 20, 2023, has been extended to April 28, 2023 due to the County still developing a process to add file extensions. The County will be on the critical path with this proposed timeline.
