Description: (Including any step-by-step instructions)	<p>Purpose</p> <p>The purpose of this CIT is to advise counties recently Opting-In to Batch EDBC run job for JB00E122D that System Change Request (SCR) CA-252519 release has been delayed until 12-03-2022.</p> <p>The Batch EDBC run job JB00E122D creates a daily batch sweep job that checks the 'Not to Exceed date (NTE)' on all FC cases with an Active status and a 5K aid code (including 5K/5L with subtype 'EC EA Eligible') and runs EDBC on those cases when the NTE has passed.</p> <p>This delay will not impact SCR CA-205633 as part of the 22.11 release which includes batch EDBC for LA County.</p> <p>Background</p> <p>SCR CA-205633 was created to expand Emergency Caregiver (EC) funding to pay 5K "EC EA Eligible" aid code to facility types where License status is 'Emergency Approval' for Tribal Specific Homes and Resource Family Homes (RFH) with the following child relationship types:</p> <ul style="list-style-type: none"> • Non-Relative Extended Family Members (NREFM) Guardian • Non-Relative Guardian

	<ul style="list-style-type: none"> • Non-Relative Non-Guardian. <p>This SCR also creates a daily batch job (JB00E122D) that checks if Emergency Assistance (EA) Not To Exceed (NTE) Date has passed on any active FC cases that use the 5K aid code and runs EDBC to update the program to the applicable aid code.</p> <p><u>Batch Job: JB00E122D</u></p> <p>Sweep Condition:</p> <ol style="list-style-type: none"> 1. FC program is 'Active' as of the batch date. 2. FC program person(s) is 'Active' as of the batch date 3. Aid code for the Foster Care program is '5K' as of the batch date. 4. The question 'Was the EA1 application approved?' in the Emergency Assistance (EA) section on the active Placement Authority is 'Yes'. 5. The 'Not To Exceed' Date in the Emergency Assistance (EA) section on the active Placement Authority has passed since the last time the batch job ran successfully. <p>*Additional counties who opted in, will be included SCR CA-252519</p> <p>County Action</p> <p>CalSAWS generates a task for the worker to take appropriate action on any program that has a foster care child that is about to reach the NTE date on the emergency assistance program.
