## Justification / Request Summary:

**Issue:**  
CalSAWS is not auto-journaling when the CF MCE household is not longer eligible when gross income exceeds 200% of the FPL for Applicant and Recipient households.

## Proposed Recommendation:

### **Recipient case: CF Household is not MCE Eligible due to excess Gross Income limit.**

#### **Blurb required:**

Household's gross income exceeded the limit for the TANF-funded service. Therefore, the household is no longer entitled to MCE, even though PUB 275 was provided to the household. The household's CalFresh benefit is terminated due to excess gross income limit.
