Description:	<p>Purpose The purpose of this CIT is to inform CalSAWS Counties of the interim process for eICT Homeless Assistance (HA) Permanent households.</p> <p>Background SCR CA-201573 eICT - Allow user to run Homeless Assistance when there's a pending CW program was implemented on 1/23/23 and will prevent a hard validation message from generating when running eICT HA Permanent cases that have pending CW/RCA program(s) at the time EDBC is run. Although the hard validation no longer prevents the user from running EDBC, the HA Permanent program may fail due to the "Not Eligible for Cash Aid" Status Reason. An additional change must be implemented to fully allow HA Permanent to pass while the accompanying CW/RCA program is in 'Pending' status.</p> <p>Additional Information: SCR CA-254466 eICT-Homeless Assistance Permanent EDBC Logic Update has been opened to remove EDBC logic resulting in a denied HA Permanent program when running on an eICT with pending CW/RCA program(s).
