The Project consolidated and assessed the county responses and subsequently received State approval of the SFY 2021-22 v7 allocations (refer to CIT 0279-22 distributed September 26, 2022) which updated allocations for the counties based on what could feasibly be accommodated through the budget. As of the October 2022 claiming cycle, a significant amount of the updated allocations has not been claimed. **County Action** The Project is requesting counties submit any outstanding claim adjustments for SFY 2021-22 by the **January 20, 2023**, monthly claim deadline.
