The last successful IEVS file was sent to us on March 1st, 2023. We do not currently have a timeline for when the file transmission will resume.</p> <p>Additional Information</p> <p>We remain in contact with DHCS, and they will deliver the IEVS Report files as soon as the issue is resolved.
