Description:	<p>Purpose</p> <p>The purpose of this CIT is to notify CalSAWS counties that a one-time list is posted for SCR CA-209184 of Non-MAGI Individuals that are Potentially eligible to the Working Disabled Program.</p> <p>Background</p> <p>SCR CA-209184 updated the following logic of the Working Disabled Program in CalSAWS per ACWDL 19-12:</p> <ul style="list-style-type: none"> • Social Security Retirement (SSR) income type was updated with a drop-down indicator that when selected, exempts the social security income that was converted from Social Security Disability (SSD) to SSR. • Veteran's Disability-Partial income type is now exempted by the system in the 250% WDP. • IHSS-Wages - Caregiver for Spouse/Minor income type is now considered a work activity for the purposes of the 250% WDP. <p>A one-time list was created to identify Non-MAGI MC beneficiaries that may potentially be eligible to the Working Disabled Program.</p> <p>Additional Information</p>

	<p>The list consists of active Non-MAGI Medi-Cal individuals with a Share of Cost who meet preliminary Working Disabled criteria who also have at least one of the following income records: Social Security Disability, Social Security Retirement, Veterans Disability – partial, or IHSS-Wages - Caregiver for Spouse/Minor.
