EDBC Mismatch Timeline/Yellow Banner

- The EDBC Mismatch Timeline that was presented at the Project Steering Committee (PSC) and Joint Powers Authority (JPA) Board meetings was reviewed with the committee.
- Counties will receive an initial EDBC Mismatch (Yellow Banner) list. After conversion, staff with the appropriate security profiles in the counties can generate an updated list anytime by going to Reports > Business Intelligence > Operations Reports > Converted Case Review Dashboard. The report can be exported to several formats including PDF and Excel.

	<ul style="list-style-type: none"> EDBC Mismatches occur during Conversion only. County staff must resolve the mismatch for the case to be fully converted.
Individuals Included on the EDR	<ul style="list-style-type: none"> Discussion on how the current criteria to determine if someone should be included in the EDR needs to be revisited. Counties shared examples of some of the issues they encounter. A separate meeting will be scheduled to further discuss this item and get additional feedback from the counties.
