- 1) Currently, variable 'ExcessMedicalExpense' on the budget populates the Medical Expense Deduction correctly for aged/disabled households (CT322 type 30). This variable currently does not populate CalFresh Standard Medical Expense (CT322 type 89) when it is available on the "EDBC Person Line Item Detail - CF Deductions" Window.
- 2) Currently, variable 'ExcessShelterCosts' on the budget populates the Allowable Shelter Costs as Housing Expenses for a case that is discontinued for over income and the customer does not have excess housing costs. In their CF budget, the housing cost is \$0.00 and the NOA shows the amount of income that is used to determine excess income.
- 3) Currently, the budget does not have a line to populate the Allowable Shelter Deduction amount as displayed on the EDBC summary for Allowed shelter Costs.
- 4) CF Recertification Approval NOA currently lists the full benefit amount.
