<b>Description:</b> (Including any step-by-step instructions)	<p><b>Purpose</b></p> <p>The purpose of this CIT is to notify Santa Cruz, San Diego, San Mateo and Solano Counties of the CalSAWS Training Environment Roadshows for Wave 4. These roadshows will provide an introduction to the CalSAWS Training Environment solution. Additional roadshows will be offered for the Wave 5 and 6 counties approximately four to six weeks ahead of each wave's Go Live date.</p> <p><b>Background</b></p> <p>The CalSAWS Training Environment Roadshows were introduced in CRFI 23-061 Request for CalSAWS Training Staging Environment Access (Wave 4). Three sessions are being offered. They are designed to provide information on the CalSAWS training environments that the Counties will have access to for their training needs. Each roadshow will cover the CalSAWS Training Staging and the CalSAWS Training Production environments, which will be made available to Santa Cruz, San Diego, San Mateo and Solano Counties in late May 2023.
