Due pro De pro resi	e to the Public Health Emergency (PHE), counties have not been required to cess Medi-Cal renewals since the year 2020. Per MEDIL 1 23-02 issued by the partment of Health Care Services (DHCS) on January 10, 2023, federal legislation vided an end date to the continuous coverage requirement enacted as a cult of the PHE. Effective April 1, 2023, counties resumed renewal activities ginning with beneficiaries with June 2023 renewal dates.

As a result, several system changes were blemented to allow these protections, which included turning off the autocontinuance batch for beneficiaries who did not submit their Medi-Cal ewals.
