Description: (Including any step-by-step instructions)	Purpose The purpose of this CIT is to provide the Wave 6 CalWIN counties (Sacramento, San Francisco, and San Luis Obispo County) with the Learning Management System (LMS) Guide for CalSAWS General Training. Background CalSAWS General Training participants in Sacramento, San Francisco, and San Luis Obispo Counties will be able to access the CalSAWS LMS to complete their webbased training (WBT) starting Monday, June 5, 2023. Training has been assigned in collaboration with each county based on staff roles. Select staff will receive only web-based training as their assignment, while most staff will receive their webbased training assignment as a prerequisite to attending CalSAWS Instructor-led Training (ILT). The attached LMS Guide for General Training provides instructions for accessing the CalSAWS LMS for the first time, accessing your assigned CalSAWS training curriculum, using the Learning Journey Map to navigate your curriculum, and submitting a ServiceNow (SNOW) ticket for LMS issues and questions (there are different versions of the guide, based on county request, attached to this CIT as

noted below).
