(Per CIT 0192-23) are included in the list for easy reference. This IE status could be returned for online or automated Redeterminations, Report a Change/Change in Circumstances (RAC/CIC) or Applications. Workers may refer to the list to see the comprehensive list of individuals for their county.</p> <p>The county worker should evaluate the individuals on the list.
