Description: (Including any step-by-step instructions)	Purpose The purpose of this CIT is to update the Go-Live Packet (GLP) for Wave 4 CalWIN Counties (Solano, Santa Cruz, San Mateo, and San Diego). Background The goal of the GLP is to consolidate information that will help users when they start using CalSAWS and promote knowledge-building, so users can become self-sufficient more quickly after Go-Live. Wave-4 County users have successfully completed their CalSAWS Web-Based Trainings (WBTs). Users have also participated in Change Discussions to understand the key changes between CalWIN and CalSAWS. They are now in the process of completing detailed Instructor-Led Training (ILT) to prepare them for the Wave-4 counties cut over to CalSAWS (07/03/2023). At that time, users may need additional assistance in specific situations when they begin using CalSAWS. The GLP has been created to address this need and will serve as a key resource for new CalSAWS users. The GLP includes the following:
---	---

- Additional Post Go-Live data cleansing that may be required in specific scenarios.
- Known behavior of CalWIN converted cases, which may require user intervention or awareness.
- Additional resources that are available for County users to build their CalSAWS knowledge.
- Directions on how to get help during the first 60-Days Post Go-Live and following the 60-Day Post-Implementation period.

Additional Information

This version of the GLP includes the following changes from the Wave-3 version distributed on 02/28/2023:

- Removed 2 items from the *What I need to Act On* document.
- Removed 3 items from the *What I need to Know* document.
- Added 5 new items to the *What I need to Know* document.
- Updated CalSAWS 2023 Batch Calendar details for the remaining months

County PPOCs/IPOCs are responsible for distributing the Go-Live Packet (GLP) Orientation Sessions.

GLP Orientation Sessions will be held to familiarize county managers and supervisors and lead them through various scenarios on use of the packet. The ISS Training team will then remind participants in Training Practice Labs about the GLP and provided an overview of what it is and how to use it.
