Description:	<p><b>Purpose</b></p> <p>The purpose of this CIT is to notify CalSAWS counties that the one-time lists have been posted for CA-252970: 2023 Medicare Catastrophic Coverage Act Spousal Impoverishment Caps.</p> <p><b>Background</b></p> <p>On May 30, 2023, per <a href="#">ACWDL 23-01</a>, SCR CA-252970 updated the 2023 income and property values for the Medicare Catastrophic Coverage Act Spousal Impoverishment Caps. The values were updated as follows:</p> <ul style="list-style-type: none"> <li>• Community Spouse Resource Allowance (CSRA):           <ul style="list-style-type: none"> <li>◦ Effective 01/01/2023 the CSRA was updated to \$148,620.00.</li> </ul> </li> <li>• Maximum spousal income allocation/Minimum Monthly Maintenance Needs Allowance (MMMNA):           <ul style="list-style-type: none"> <li>◦ Effective 01/01/2023 the MC LTC Community Spouse Needs Allowance was updated to \$3,716.00.</li> </ul> </li> </ul> <p><b>Additional Information</b></p>

Note: List was removed as there were no cases that met the list criteria (no cases on the list).</p> <p>2. <b><u>List Name: 2023 LTC with Share of Cost</u></b>  A list of MC programs where an EDBC was run for the benefit month of 01/2023 through the date of implementation of this SCR, which includes a LTC budget with a share-of-cost and a spousal income allocation was performed.</p> <p><b>Additional Column(s):</b> Benefit Month(s)  Note: Benefit Month(s) will list each EDBC benefit month in the same row, separated by a comma.
