### **Conversion Readiness - Wave 4**

Conversion defects not resolved prior to Wave Go-Live (Risk 280)	As of 6/5/23, the Conversion and Release Management teams maintain a schedule deploying and resolving "89" defects by Wave 4 go-live. There are 22 Post Cutover defects that are planned within the first 10 days after county being live as these defects need production data. These Post Cutover defects will be evaluated and documented in the W4 Go-Live Packet (where applicable) with Worker Actions.  Note: the number "22" is as of 6/5/23 and could change if any new defects are identified before Wave 4 go-live. Accenture team meets with QA and Consortium on a weekly basis to discuss approximately 20 post cutover defects and prioritize all Fiscal related defects to be deployed as high priority after Wave 4 cutover. This prioritization is to address the fact that Wave 4 implementation is after 1st of July and closer to monthly fiscal processing.	Project
