Description:	Purpose The purpose of this CIT is to provide Wave 5 Counties with information on a focused training for Community Based Organizations (CBOs) that will be using the BenefitsCal (BC) portal. Background Beginning September of 2021, the CalSAWS project began rolling out the new BenefitsCal system to replace the C4Yourself (C4Y), Your Benefits Now (YBN), and MyBenefits CalWIN (MyBCW) applications where customers could apply for and manage benefits. CBOs will have the ability to submit applications on behalf of customers through BC after they have been approved by either a county or CDSS. Additional Information The BC team previously held CBO Awareness Trainings for county CBOs and existing CalSAWS CBOs to provide the workflow for the new process. Trainings were conducted: ✓ Wave 1 - September 2022 (Placer and Yolo) ✓ Wave 2 - January 2023 (Contra Costa, Santa Clara, Tulare) ✓ Wave 3 - March 2023 (Orange, Santa Barbara, Ventura) ✓ Wave 4 - May 2023 (San Diego, San Mateo, Santa Cruz, Solano)
