Description:	<p><b>Purpose</b> The purpose of this CIT is to notify Wave 4 Counties (San Mateo, Santa Cruz, and Solano) of the intent to distribute the Post Go-Live Change Readiness Survey.</p> <p><b>Background</b> The Post Go-Live Change Readiness Survey is intended to assess county internalization and adoption of CalSAWS 6 weeks after go-live. The results will assist in driving the organizational change management (OCM) approach to improve communications and other resources for subsequent go-live waves. Only internal stakeholders from each county will be assessed in the surveys.</p> <p>The surveys will be sent directly to the internal stakeholders as provided by the Wave 4 Counties per CRFI 22-053. This survey will assess change metrics for <b>"Reinforced Expectations."</b></p> <p><b>Additional Information</b> One week prior to survey launch, an email from <b>Bri South</b> will inform Wave 4 PPOCs/RMs/IT staff of the survey testing process.
