- All **historical** (or previously generated) scheduled reports prior to August 31, 2023, for the 52 CalSAWS counties will be available on Monday, September 04, 2023, in CalSAWS.
- Wave 5B cutover data will have the data for Active cases and Closed cases within the last two years. Historical data (closed cases older than two (2) years) for Wave 5 counties will be available with subsequent cutover events.
- A separate CIT will be distributed for Reports and Dashboards' availability for Wave 5C cutover.

- Friday (9/01/2023) batch processing in CalSAWS is projected to complete early Saturday morning, 9/02/2023.

- Replication to Enhanced Data Reporting (EDR) will be paused after completion of Friday night (9/01/2023) batch.
- Existing CalSAWS counties will continue to have EDR access throughout the cut over weekend.
- Replication to EDR will be resumed approximately by 6:30 AM on Monday, 9/04/2023 after the completion of Wave 5B Cutover.
- EDR is expected to be in sync with real-time Production data starting Tuesday, 9/05/2023 at 6:30 AM.
- Generation of Daily Reports and Dashboards will begin on Tuesday, 9/05/2023 evening (Batch window) for access, in CalSAWS, by Wednesday, 9/06/2023. Note: Catch up may take until the EOD on Wednesday, 9/06/2023.
- Daily reports for Saturday 9/02/2023, Sunday 9/03/2023, Monday 9/04/2023 and, Tuesday 9/05/2023 will be available by EOD on Wednesday 9/06/2023.
