Current Design: SCR CA-248917 updated the statewide minimum wage to \$15.50, as of 01/01/2023. This value is used in the CalFresh Work Incentive Nutritional Supplement (WINS) proxy calculation.

Request: Per ACIN I-61-23 effective January 1, 2024, the statewide minimum wage will increase to \$16 per hour.

Recommendation: 1) Apply a CTCR to update the State Minimum Wage (CT 335 - MW) to \$16 by inserting a new record effective 01/01/2024. The current High-Dated record will be end-dated effective 12/31/2023.

Note: The WEX/CS Worksheet Detail page uses the current value of Minimum wage for calculation as per the original design. This page was not intended to use for prior month's calculations, so if the user selects month/year in a prior year, the system will use the current year's Minimum wage value instead of the prior year's value.
