Description:	<p>Purpose The purpose of this CIT is to notify CalSAWS CAPI Counties that lists for CA-243003 (ACIN I-66-23 Cash Assistance Program for Immigrants Cost of Living Adjustment (CAPI COLA) Batch EDBC have been posted to the CalSAWS Web Portal.</p> <p>Background On Thursday, December 07, 2023, CA-243003 updated the CAPI Payment Standard amounts and ISM Presumed Maximum Value (PMV) amounts because of an increase in the standard rates of Supplemental Security Income (SSI) payments effective 01/01/2024.</p> <p>Additional Information SCR CA-243004 Batch EDBC was run on Friday 12/08/2023. This applied the new COLA values for the CAPI program for the January 2024 benefit month. The Batch EDBC for CAPI programs will apply the new payment standards and PMV amounts along with CF/NB programs that have a CAPI participant in common. The Batch run will be for the benefit month of 01/2024 and will run in the following order: 1) CAPI programs.</p>

- 2) CF programs with a CAPI participant in common. **Note: CF cases can be in a different county from the CAPI case such as CAPI programs administered by Sacramento and San Mateo counties where the CF case is in the residing county of the CAPI individual.**
