Description:	<p><b>Purpose</b> The purpose of this CIT is to provide CalSAWS Counties with an update regarding the BenefitsCal production Administrator (Admin) role. This role has been removed for county use.</p> <p><b>Background</b> BenefitsCal has functionality that is only accessible through the BenefitsCal Admin role. This role allows the User to make changes to certain parts of the production system including adding announcements, updating county options, and uploading How-to Videos. A review of the functionality identified a concern that allows the role to also modify Terms &amp; Conditions, Frequently Asked Questions (FAQs), and the Glossary.</p> <p><b>Additional Information</b> After a review of this functionality, it was determined that it does not meet current security protocols and has been removed from county access. A new process is now in place for completion of needed changes for the counties. The BenefitsCal Admin role is now limited to the CalSAWS and BenefitsCal project staff. All functions of the BenefitsCal Admin role will be completed by the project staff with communication to Counties.</p> <p><b>County Action</b></p>
