Issue:

When AAP, FC, or KG youth are not eligible for extended benefits; their payments must not continue past the age of 18. Also, when they turn 21, they are no longer eligible for payments. Currently eligibility workers must run EDBC for the appropriate months to make sure the grant ends appropriately and to prevent overpayments.

Proposed Recommendation:

Apply functionality from [\[CA-203787\] Auto Discontinue of AAP When Youth Turn 18/21 and Update NA 791 - CalSAWS Change Management](#) to Santa Clara County. Include Foster Care and Kin-GAP to the batch job.
