Batch Memorandum for 2024 CAPI COLA

Batch Memorandum provide expectations & outcomes. Final Memorandum Will be sent out as CIT.

Have not received final ACIN yet but amounts are confirmed. Will send out once ACIN number is received. Will have some batch date changes.

CA 243003 – on Thursday December 7, 2023 will update latest 2024 payment standards & ISM PMV amounts.

CA 243004 – on Saturday December 9, 2023 will process batch EDBC to apply the 2024 CAPI COLA. Date may change due to other COLAs. Possibly moved to Friday December 8, 2023.

Batch run will apply to CAPI only cases first & then CAPI with CalFresh.

Exclusions will apply on certain criterias.

Journal entry will be included for batch runs.

NOAs will generate.

Statistical reports will be generated & include counts, processed, skipped, success rates.

Lists will be posted to aid counties to review cases to verify accurate actions. Will be generated by Regions. Will not include yellow banner cases. Those will be on Qlik dashboard.

Looking at 15,000 CAPI cases & 3300 with CalFresh.
