Background

The EBT Theft List and Detail pages were added to CalSAWS as a method to track the receipt of the EBT 2259 form, both through electronic submission from BenefitsCal as well as manual entry by a worker, for counties who wish to use these pages.

Additional Information

EBT 2259 forms electronically completed by the customer through the Self-Service Portal (SSP) automatically generate an EBT Theft record pre-populated with the information provided by the customer along with a task and a journal entry. The

	auto generated EBT Theft record created through the SSP remains in an In-Process status until it is updated by the user.
