Summary: This Change Notice will utilize \$2,308,378 of the \$167,000,000 Regulatory and Administrative Change Budget Services for the following five Premise Items: CalFresh Eligibility Disqualifications for Certain Convicted Felons (\$744,990), CalFresh Restaurant Meals Program Notice-Eligibility Clarification (\$488,798), CalFresh Notice of Denial or Pending Status (\$372,829), CalFresh Notice of Denial or Pending Status (\$201,821), Resume Pre-Pandemic Medi-Cal Operations (\$499,940). This Change Notice also includes state fiscal year shifts associated with two previously approved premise items, CalFresh Discontinuance of Gambling Wins and CalFresh Reinstatement Approval and Denial Notice Revisions. Board approval of this Change Notice will leave \$49,152,051 for future work.

This Change Notice includes routine WAN upgrades and site location updates. This is a no-cost update.

This Change Notice will also utilize \$68,322 of the original \$35,000,000 allocation for County Purchases subject to Board approval. Board approval of this Change

Notice will leave \$14,043,917 for future County Purchases. The County purchase included in Change Notice 34 is as follows:

c. Approval of ClearBest Work Order 6, which includes seven (7) Premise items.

Summary: This Work Order will utilize \$259,722 of the \$8,829,000 Professional Services allowance for seven (7) premise items: CalFresh Eligibility Disqualifications for Certain Convicted Felons (\$66,903), CalFresh Restaurant Meals (\$42,318), CalFresh Notice of Denial or Pending Status (\$35,094), CalFresh Reinstatement Approval & Denial Notice Revisions (\$48,813), Update CalFresh Discontinuance of Gambling Wins (\$5,130), CalFresh and CalWORKs Implementation of New Forms and CDSS Rights Contact Information Update (\$18,234), and Resume Pre-Pandemic Medi-Cal Operations (\$43,230). Board approval of this Work Order will leave a balance of \$5,222,063 for future work.

The costs of this Work Order are funded through premise funding and accounted for in the SFY 2024-25 CalSAWS JPA Project Budget.

d. Approval of Gainwell Central Print Change Order 2, which includes three (3) county purchases.

Summary: This Change Order will utilize \$110,978 of the original \$9,000,000 allocation for County Purchases subject to Board approval. Board approval of this Change Order will leave \$8,770,485 for future County Purchases. The County Purchases included in Change Order No. 2 are as follows:
