<p>CA-265708 – Cancel Application Status</p> <ul style="list-style-type: none"> Dates are important for running EDBC and may still be required even w/application opened in error. County is willing to change things in the CER, however design details are finalized in SCR overviews and design discussions. 	<ul style="list-style-type: none"> Question was asked if it would be easier to update the rights of Office Staff? However, all counties decide their own securities. Policy concerns regarding a Cancel status, CER will be forwarded to Eligibility to address concerns when appropriate. CER Approved.
<p>CA-270386 – Autofill Journal</p> <ul style="list-style-type: none"> Common questions from the counties is - if the Auto-Filled journal could be edited. The answer was yes. Would this auto filled journal be compliant with the State for Fair Hearings, follow-up would be needed to be sure, but they did not see why not. 	<ul style="list-style-type: none"> Counties would like this for use at application, at RE, at SAR and so on. Counties would like this to be an opt-in or opt-out functionality. Consortium unsure if this is feasible. CER Approved.
<p>CA-277998 – Language on Reapplication</p> <ul style="list-style-type: none"> Since language is person level, whose language is being updated at reapplication? Answer - the Primary applicant only. Isn't it already pulling the language from the individual demographics screen? Answer - yes but that some clients change their language on their applications in some counties. 	<ul style="list-style-type: none"> Concern over this being a required field – excellent questions once we are into design. CER Approved.
<p>CA-276330 – Race/Ethic Origins Added</p> <ul style="list-style-type: none"> Question asked - would we need the permission of the State as this information is tracked by the State? Yes the information is tracked by the State but not known if we needed their buy-off. Will share with the State reports committee. 	<ul style="list-style-type: none"> Unsure how this new information would transfer to MEDS. 'Decline to State' is a valid reason in MEDS, and Other is also a Valid Reason. When Asian or Hispanic is chosen it is assumed it would follow the same logic as it does now. CER Approved.
<p>CA-279413 – Remove EDBC Accept Button from top of Page</p> <ul style="list-style-type: none"> Most counties felt that this was a training issue and did want to move straight to voting. 	<ul style="list-style-type: none"> CER was rejected.
