Description: Purpose

The purpose of this CIT is to provide counties with updates being made to the Child Health and Disability Prevention (CHDP) Program within CalSAWS.

Background

CHDP provided preventive health, vision, dental screenings and care coordination to children and youth under the age of 21 who were enrolled in Fee-For-Service (FFS) Medi-Cal. The CHDP Program was locally administered at the county level through annual budget allocations from Department of Health Care Services (DHCS).

Per ACWDL 24-09, effective July 1, 2024, the CHDP program has sunset/ended. The CHDP Gateway functionality will be retained and rebranded as Children's Presumptive Eligibility (CPE).

MEDIL I 24-14 added that the use of CHDP Program flyers (PUB 183 and PUB 184) should be discontinued effective July 1, 2024. Additionally, the standalone MC 003 – EPSDT flyer is no longer required to be sent as part of the application and renewal packet as the information is contained in the "myMedi-Cal" booklet (also known as "PUB 68") distributed as part of the application packet.

Additional Information

The removal of CHDP references and forms within CalSAWS will be completed in phases with different SCRs. The following are the SCRs that will remove CHDP system functionality, forms, and references.

CA-277974 (Children's Presumptive Eligibility & The Newborn Gateway) – will remove the PUB 183/184 and MC 003 from the RE Packets. In addition, the following forms will be removed from template repository. • PA 6082 – CHDP Contact Letter (LA County specific) PM 357 – CHDP Referral (All Counties) This SCR is slated for a minor release of 24.08.29. CA-279742 (Remove the questions related to CHDP from the Health Care Referral List page) – will remove the applicable CHDP questions from the Health Care Referral List page. This SCR is slated for a minor release of 24.08.29. CA-279955 (Update on CHDP Interface) – will remove Los Angeles County CHDP interface and update San Bernardino County interface to exclude CHDP information. This SCR is slated for a minor release of 24.08.29. CA-279292 (Update Forms to no longer include CHDP references)-will remove CHDP referral references from remaining forms that have CHDP references. This SCR is slated for a future release. A future SCR will make updates to BenefitsCal. **County Action** Counties may need to adjust their business process until all references have been removed from CalSAWS and BenefitsCal.
