Description: (Including any step-by-step instructions)	<p>Purpose (Identify what Counties this CIT affects)</p> <p>The purpose of this CIT is to inform counties of the alternate process to pay Dual Agency Rates for Dual Agency children placed in a Foster Family Agency setting.</p> <p>Currently, CalSAWS does not have Dual Agency RC-California Early Start Intervention (P1) or Dual Agency RC-Lanterman Developmental Disability (P2) on the drop-down choices on the Foster Care "<u>Rate Detail</u>" page when selecting Foster Family Agency Certified Resource Family Home (FFACRFH) as a Placement Type on the Foster Care "<u>Child Placement Detail</u>" page.</p> <p>With SCR CA-277036 slated for Release 24.11, counties can follow these steps as a temporary alternative process to pay the (P1) & (P2) rates.</p> <p>Background</p> <p>ACL 24-04 now clarifies eligibility to children/Non-Minor Dependents (NMD's) placed with Foster Family Agency Resource Family Homes for the Dual Agency Rate.</p> <p>County Action</p> <p>Follow steps to pay the (P1) & (P2) Dual Agency Rates</p> <p>On the Foster Care "<u>Child Placement Detail</u>" page, after selecting the appropriate Placement Name, Placement type, and completing all mandatory fields:</p>

	<ul style="list-style-type: none"> • Click Add in the Rate List section, select Non-Standard Rate from "Type" dropdown list, and enter appropriate dollar amount in the Rate field. • Select monthly as the frequency and enter the Begin date of the rate • Save and Return and Save the page. • Run EDBC, Authorize, and Add a Journal Entry to identify actions taken. <p>*Note* These instructions do not apply to LA County since LA uses the CWS/CMS interface for rate request.
