CalSAWS was informed of an extension of federal funding for CalFresh replacement due to electronic theft through 12/20/2024. Due to this update, SCR CA-280684 has been pulled from scheduled priority release on 10/3/2024.</p> <p>'RPSNAP' EBT Benefit Type will continue to be assigned when issuing CalFresh replacement benefits due to electronic theft</p> <p>Additional Information</p> <p>CDSS is working on updated policy guidance. Please read the following informational email from the California Department of Social Services (CDSS).

As of September 25, 2024, Congress passed [HR 9747](#), the Continuing Appropriations and Extensions Act, which extends authority to replace electronically stolen SNAP benefits with Federal funding through December 20, 2024. This will allow counties to continue using the RSPSNAP benefit type through December 20, 2024. CDSS will provide updated policy guidance shortly.
