Background


Per ACL 24-16, the Office of Refugee Resettlement (ORR) directs counties to disregard cash grants that refugees and other eligible individuals receive through programs determined by ORR to be equivalent to federal Reception and Placement (R&P) program such as 'Refugee Resettlement Program' (RRP) beginning as of June 2023.

County Actions
