## **Additional Information**

**SCR CA-270653** will run Batch EDBC on 12/14/2024 for CF programs (this includes Transitional, or TCF programs) and any NB programs linked to those CF programs. This SCR will apply the new \$16.50 State Minimum Wage as of the January 2025 benefit month.
