Consortium Enhancement Request (CER) Review

CER CA-279483 Update Tax Filing status on MC RE packets

- Reviewed the Consortium Enhancement Request (CER).
- The MAGI and mixed MC RE packets have a section for the tax household (HH) status of all members, which populates with the current status in the Tax HH page. For dependent children, it does not populate who is claiming the child as a tax dependent. The CER (request) from Humboldt County is to populate who is claiming the child as a tax dependent on the MAGI and Mixed MC RE packets.
- The committee voted to move the CER forward to an SCR.

SCR CA-279292 Update Forms to no longer include CHDP references	<ul style="list-style-type: none"> CA-277974 will remove the PUB 184 and 183 from MC renewal packets and informational packets in a priority release on 24.08.29.
SCR CA-279300 Update CalSAWS to no longer trigger CHDP Referrals	<ul style="list-style-type: none"> CA-279292 will remove CHDP references in CW and MC forms. Will be implemented in a future release. CA-279300 will remove CHDP references in the System. Has been rejected since the meeting as the scope will be completed in SCR CA-279292. A CIT regarding all the CHDP system updates and SCRs will be issued. The following two SCRs were not included in the committee meeting however are being provided for your reference: CA-279955 and CA-279742. They are slated for a minor release of 24.08.29.
