The only transaction currently sending the individual's address is the EW12. This discrepancy triggers an address change for household members who have an address different from the Primary Applicant. Beneficiaries who reside in a county different than the Primary Applicant, such as students attending school and persons in LTC, are disenrolled from their existing managed care plan and enrolled in another. This SCR will send the individual's physical and mailing address with all MEDS transactions, including the RC20 and FR20.
