Background

CalSAWS was commissioned to create a replacement system for TRAC. Welfare Data Tracking Implementation Project's (WDTIP) Tracking Recipients Across California (TRAC) system will be decommissioned and migrated to its replacement, the Statewide Cash Aid Time Limits (SCATL) application. Cutover will occur May 24- May 25, 2025, and available to users May 26, 2025.

Additional Information

Historical time limit data in WDTIP will be migrated to SCATL. TRAC pages will remain available in view-only mode until June 30, 2026.
