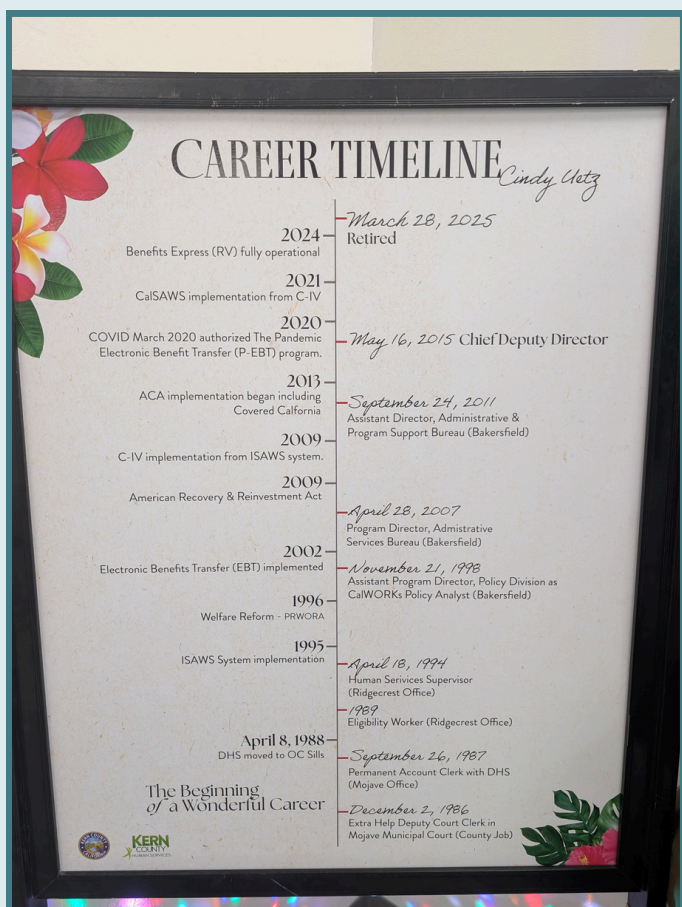


Cindy Uetz is Retiring!

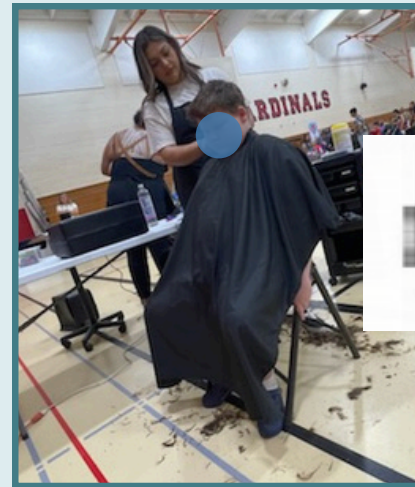

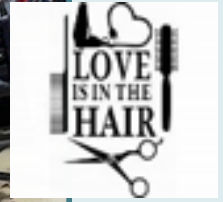
