Description

Purpose


The purpose of this CIT is to provide counties with the updated job aid titled JA Cash Aid Time Limits which will be available in the Online Help with the 25.07 release. It reflects functionality changes that accompany the implementation of the Statewide Cash Aid Time Limits (SCATL) application.

Background

CalSAWS was commissioned to create a replacement system for TRAC. Welfare Data Tracking Implementation Project's (WDTIP) Tracking Recipients Across California (TRAC) system will be decommissioned and migrated to its replacement, the SCATL application. Cutover will occur May 24 - May 25, 2025, and will be available to users May 26, 2025.
