Description

Purpose

The purpose of this CIT is to inform counties of the lists associated with **CA-219304 ACL-24-01 CF Restaurant Meals Program Eligibility Program Updates and CF 889**.

Background

Previously, all CalFresh households containing at least one member who was considered elderly, disabled, or homeless were eligible to participate in the Restaurant Meals Program (RMP). This included CalFresh households with members who were not eligible to participate in the RMP based on the RMP eligibility criteria.

Per ACL 24-01, RMP eligibility must only be allowed for CalFresh households where all members are eligible for the program. Meaning that for the household to be eligible for the RMP, all members of the household must be adults aged 60 and older (and their spouses), people with disabilities (and their spouses), or individuals experiencing homelessness. Please note, spouses do not have to meet the age or disability criteria. Households that include at least one member who do not meet RMP eligibility criteria are ineligible for the RMP.

A one-time batch sweep was run to terminate RMP access from existing CF households that are no longer eligible for RMP.

List of Cases Discontinued by Batch EDBC Process.	These are likely the result of household changes or ongoing data collection which was not yet processed through EDBC by the user. Since the purpose of this Batch EDBC process was not to close households, review these cases to verify the closure was accurate.
List of Cases Where the Batch EDBC Process Closed a Person.	These are likely the result of household changes or ongoing data collection which was not yet processed through EDBC by the user. Since the purpose of this Batch EDBC process was not to terminate a person o CF (only RMP), review these cases to verify the closure was accurate.
List of Cases Where the EDBC Resulted in a Benefit Reduction	These are likely the result of household changes or ongoing data collection which was not yet processed through EDBC. Since this Batch EDBC process should not have resulted in benefit reduction, review these cases to verify the benefit reduction was accurate.

	List of Cases Which Resulted in a Read-Only EDBC.	Since Batch EDBC could not automatically apply the intended change to these cases, users may process EDBC to apply intended changes, if applicable.
