**Change Order Number Three**

**CalSAWS CENTRAL PRINT SERVICES AGREEMENT (“AGREEMENT”) ENTERED INTO BY AND BETWEEN THE CALSAWS CONSORTIUM (“CONSORTIUM”), A CALIFORNIA JOINT POWERS AUTHORITY, AND GAINWELL TECHNOLOGIES LLC (“CONTRACTOR”) FOR THE PROVISION OF THE CALIFORNIA STATEWIDE AUTOMATED WELFARE SYSTEM (“CalSAWS”).**

Pursuant to Section 7.2 (No Increases) of Section 7 (Payments; Invoicing; and Related Financial Terms) of the Agreement, CONSORTIUM and CONTRACTOR agree to not increase the Contract Sums or the Total Maximum Contract Sum. CONSORTIUM and CONTRACTOR hereby agree to the following modifications to the Agreement:

1. **Alternate Formats.** In support of the Premise project to incorporate alternate format Medi-Cal related correspondence, the following line items and rates are added to the Agreement.

Subsequent to the approval of this Change Notice Number Three, the balance remaining from the Thirty Two Million One Hundred Thousand dollars (\$32,100,000) in approved funds for Print Services Change in Agreement Exhibit C will be Twenty Seven Million Seven Hundred Ninety One Thousand Eight Hundred and One dollars (\$27,791,801).

This Change Order Number Three shall be effective upon execution by CONSORTIUM and CONTRACTOR.

Except for those terms of the Agreement expressly modified by this Change Order Number Three, all other terms and conditions of the Agreement shall remain in full force and effect.
