Description

Purpose

The purpose of this CIT is to notify counties that the GetCalFresh (GCF) application assistance tool will retire on June 30, 2025, and all online CalFresh applications will be submitted via BenefitsCal starting July 1, 2025. This CIT provides guidance on steps counties should take to support this transition and provide awareness of the change.

Background

GCF has served as an online application assister for CalFresh benefits since 2014. The California Department of Social Services (CDSS) published All County Welfare Directors Letter (ACWDL) dated April 15, 2025, which confirmed the GCF application assistance tool will retire on June 30, 2025. This change is part of a statewide effort to streamline online access to public benefits. Beginning July 1, 2025, BenefitsCal will serve as the only platform for submitting online CalFresh applications.

The GCF domain and subpages will remain active beyond September 30, 2025. While a redirect notice will appear on the GCF homepage, counties are responsible for reviewing and updating all internal and public-facing materials to reflect the transition about how to apply for CalFresh.
